- Bidding shall be conducted through E-Procurement (**Single Stage Two Envelope**) as specified in the Punjab Procurement Rules PPRA 2014 which is open to all eligible bidders as defined in the bidding document.

- E-bids will be opened under PPRA Rule 30(1) in presence of bidders or their representatives.
- All Bids must be accompanied by a Bid Security of 4% of the estimated bid value, to be deposited electronically through facility available at Punjab e-Procurement System (EP).
- The bidder shall upload a duly signed Affidavit on the prescribed Stamp Paper, along with the bid documents on the Punjab e-Procurement System (EP). However, the Procuring Agency reserves the right to require the successful bidder or any bidder, at any stage of the procurement process, to produce the original Affidavit for physical verification, if deemed necessary.
- The Bidders must adhere to the minimum wage rate (notified by Labour & Human Resource Department), all applicable taxes (imposed by FBR/PRA/GST/any other government organization) and contributions (PESSI, EOBI) while preparing financial bid.**
- Bid Validity will be 180 days.
