B SHORT TITLE AND COMMENCEMENT

Short Title means, Admission Regulations. These Regulations shall come into force with immediate effect.

1 **DEFINITIONS**

In these Regulations, unless the context otherwise requires, the following expressions shall have the meaning hereby respectively assigned to them; that is to say:

- i. "Academic Year" means the period of year during which the students attend University.
- ii. "ASRB" means Advanced Studies and Research Board.
- iii. "Candidate" means applicant for admission in any program of the University.
- iv. "Chairperson" means chairperson of academic department of Lahore College for Women University Lahore.
- v. "Department" means the Academic Department of Lahore College for Women University Lahore.
- vi. "Program" means a broad area of study for specific types of degree paths over a specific period of time.
- vii. "Student" means the student studying at Lahore College for Women University Lahore.
- viii. "University" means Lahore College for Women University Lahore.

- 2.2. The University authority reserves the right not to advertise/offer any regular/self-supporting program/area of specialization as per availability of resources and/or as per regulatory requirements.
- 2.3. The University authority reserves the right to withdraw/ withhold admission of any advertised subject / discipline / Program without assigning any reason.
- 2.4. The University authority reserves the right to cancel the admission in case number of applications/ admissions is insufficient.
- 2.5. The University authority reserves the right to offer any new program after approval from statutory bodies and taking NOC from HEC (If applicable).
- 2.6. There is no age limit for admission at all program levels.

3 ADMISSION PROCESS

3.1. ADVERTISEMENT IN NEWSPAPERS AND UNIVERSITY WEBSITE

3.1.1. Admission Advertisement shall be published in National Newspapers and university website. All the offered programs along-with eligibility criteria, test and interview schedule will be published on website.

3.2. ADMISSION FORM SUBMISSION

3.2.1. University Prospectus along with the admission schedule will be uploaded on University Website (www.lcwu.edu.pk). The candidates interested in admission shall apply after carefully filling the admission form and attaching all relevant documents as per instructions provided on the University website.

3.3. ADMISSION PROCESS FOR PHD DEGREE PROGRAMS

3.3.1 ELIGIBILITY CRITERIA

- 3.3.1.1 Female candidates with minimum Eighteen years of education (MPhil/MS) or equivalent in the relevant field are eligible to apply.
- 3.3.1.2 The candidate must have obtained 3.00/4.00 CGPA in semester system or 60 % Marks in annual system, in her last degree (Level 7).
- 3.3.1.3 Entry test and consent from potential supervisor is mandatory for admission in PhD program.
- 3.3.1.4 Foreign degree holders must produce equivalency certificate from HEC.
- 3.3.1.5 If CGPA/Percentage is not mentioned on the transcript, the candidate must produce equivalent weightage from the parent university. The document must be duly signed by Controller of Examinations or Registrar of the University (Equivalent office in case of foreign degree).
- 3.3.1.6 A candidate having CGPA below 3.00 (out of 4.0 in the semester system) but above or equal 2.50 CGPA in MS/M.Phil./Equivalent degree program may be considered for provisional admission in PhD program after fulfilling the following additional requirements:
 - The student shall study additional courses of 12 credit hours of level-7 taking a zero semester.
 - ii. The admission shall only be confirmed if student scores minimum 3.00 out of 4.00 CGPA in zero semester. In case of failure to obtain required CGPA, the admission of student shall stand cancelled.
 - iii. The Departmental Admission Committee is satisfied that the applicant's knowledge of primary area (level 7) has sufficiently prepared her to undertake the course of studies of the doctoral program.
- 3.3.2 The potential candidates shall be required to submit admission form along with research proposal and choice of potential Supervisor/s.

- 3.3.3 The concerned Academic Department shall scrutinize the submitted admission forms against the basic eligibility criteria.
- 3.3.4 Candidates who qualify the basic eligibility criteria of the concerned academic department shall be declared eligible to appear in the university admission test, as per prescribed date / schedule. The list of eligible / provisionally eligible candidates, prepared by respective department, for admission test will be uploaded on university website along with the prescribed date/schedule, by the Registrar Office through Web Office.
- 3.3.5 Only those candidates, who qualify the University Admission test as per LCWU/HEC policy, shall be declared eligible for interview. The list of eligible / provisionally eligible candidates, prepared by respective department, for interview will be uploaded on university website along with the prescribed date/schedule, by the Registrar Office through Web Office.
- 3.3.6 The interview shall be conducted by the potential supervisor who is first in the order of priority given by the candidate at the time of filling the admission form.
- 3.3.7 In case potential supervisor who is first in the order of priority does not give consent to accept the candidate in his/her supervision, the candidate shall be referred to next potential supervisor in the order of priority, and so on.
- 3.3.8 Only those candidates who shall successfully secure supervisor's consent shall be eligible for admission.
- 3.3.9 Final Merit Lists will be prepared by the respective department and will be displayed on University Website, by the Registrar Office through Web Office. The merit list shall also mention name of supervisor against the name of candidate along with other necessary information.
- 3.3.10 The candidates shall be required to visit respective department of University along with original documents for verification on the prescribed date/schedule.
- 3.3.11 After successful verification of the original documents, the respective department shall issue an admission slip to the candidate. The admission fee challan shall be issued by Fee Section of Treasurer Office in lieu of that admission slip. The candidates shall submit the Fee and shall submit the receipt to respective department for issuance of Roll No.

3.3.12 ADMISSION FORMS REQUIREMENTS

- 7. Statement of Purpose. This may would, at least, include the following:
 - i. Title of the potential research proposal
 - ii. Clear articulation of the current understanding of the intended field and ideas for potential research
 - iii. Explanation of the intended impact of the proposed research
 - iv. The prospective candidates shall demonstrate passion and enthusiasm for the area of research.
- 8. List of published research papers (optional)
- 3.3.13 If at any stage after the admission it comes to the knowledge of the university authorities that the documents presented by the candidate are fake or there is a misstatement or clerical error in the documents, her admission will be cancelled.

3.4 ADMISSION PROCESS FOR MS/M.PHIL/EQUIVALENT DEGREE PROGRAMS

3.4.1 ELIGIBILITY CRITERIA

As per LCWU/HEC policy for admission in MS/M. Phil/Equivalent programs, the female candidates must meet the following eligibility criteria:

3.4.1.1 Sixteen years of schooling or 4 year education (minimum 120 credit hours) after HSSC/F.A./F.Sc./Grade 12 or Equivalent shall be required for admission in the MPhil/MS/Equivalent program.

- 3.4.1.2 The candidate must have secured 2.50/4.00 CGPA in semester system or 50% marks in annual system in her last degree (level 6). For language discipline, 45% marks shall be required in annual system.
- 3.4.1.3 University Admission Test with passing score of 50% along with interview conducted by Departmental Admission Committee is mandatory for admission in MS/MPhil/Equivalent program.
- 3.4.2 The respective Departmental Admission Committee shall scrutinize the online submitted admission forms.
- 3.4.3 The candidates who qualify the basic eligibility criteria of the respective program shall be declared eligible to appear in test on prescribed date / schedule. The list of eligible / provisionally eligible candidates, prepared by respective department, eligible for admission test will be uploaded on university website along with the prescribed date/schedule, by the Registrar Office through Web Office.
- 3.4.4 The candidates who qualify the University admission test, as per LCWU/HEC policy, shall be eligible to appear in the interview.
- 3.4.5 The list of eligible / provisionally eligible candidates, prepared by respective department, for interview will be uploaded on university website along with the prescribed date/schedule, by the Registrar Office through Web Office. The interview shall be conducted by the Departmental Admission Committee.
- 3.4.6 Final Merit Lists will be prepared by the respective department and will be displayed on University Website, by the Registrar Office through Web Office.
- 3.4.7 The candidates shall be required to visit respective department of University along with original documents for verification on the prescribed date/schedule.
- 3.4.8 After successful verification of the original documents, the respective department shall issue an admission slip to the candidate. The admission fee challan shall be issued by Fee Section of Treasurer Office in lieu of that admission slip. The candidates shall submit the Fee and shall submit the receipt to respective department for issuance of Roll No.

3.4.9 ADMISSION FORMS REQUIREMENTS

- 3.4.9.2 If at any stage after the admission it comes to the knowledge of the university authorities that the documents presented by the candidate are fake or there is a misstatement or clerical error in the documents, her admission will be cancelled.

3.5 ADMISSION PROCESS FOR BS/EQUIALENT DEGREE PROGRAMS

3.5.1 **ELIGIBILITY CRITERIA**

- 3.5.1.1 Candidates having Intermediate (HSSC) / 'A' level/ equivalent qualification in any discipline with at-least 50% marks are eligible for admission in the following BS/Equivalent programs: International Relations, Political Science, Home Economics, Pakistan Studies, History, Mass Communication, Social Work, Gender and Development Studies, Sociology, TESOL, Persian, Punjabi, Urdu, Arabic, Islamic studies and in different specializations of Bachelor of Education (B.Ed.) program i.e., Elementary Education, Secondary Education, Educational leadership & Management, and Educational Assessment & Evaluation.
- 3.5.1.2 Candidates having Intermediate (HSSC) / 'A' level/ equivalent qualification in any discipline with 2nd Division are eligible for admission B.Ed. (Specialization: Special Education, Educational Research & Policy Studies, Educational Policy Studies and Sustainability, Early Child Care and Education, Sustainability and Life Long Learning, and Educational Entrepreneurship).

- 3.5.1.3 Candidates having Intermediate (HSSC) / 'A' level/ equivalent qualification in any discipline with 1st Division are eligible for admission B.Ed. (Specialization: Information Technology).
- 3.5.1.4 Percentage of marks may be relaxed by the Vice Chancellor on the recommendation of concerned Chairperson, if seats are available.
- 3.5.1.5 The eligibility criteria of the academic programs under the Accreditation Councils will be as per their relevant Council requirement.

3.5.1.6 ELIGIBILITY CRITERIA FOR BS HEALTH & PHYSICAL EDUCATION

Female candidates having intermediate (HSSC) / A-Level / Equivalent to intermediate with at-least 50% marks are eligible to apply for BS program.

3.5.1.7 ELIGIBILITY CRITERIA FOR BS BOTANY, BS BIOTECHNOLOGY, AND BS ZOOLOGY

Female candidates having Intermediate (HSSC) / 'A' Level / Equivalent qualification to F.Sc. Pre-medical, with at least 50% marks are eligible to apply for BS programs

3.5.1.8 ELIGIBILITY CRITERIA FOR BS CHEMISTRY AND BS ENVIRONMENTAL SCIENCE

Female candidates having Intermediate (HSSC)/ 'A' Level / Equivalent qualification to F.Sc. Pre-Medical / F.Sc. Pre- Engineering with at least 50% marks are eligible to apply for BS programs.

3.5.1.9 **ELIGIBILITY CRITERIA FOR BS GEOGRAPHY**

Female candidates having Intermediate (HSSC)/ 'A' Level / FA / F.Sc. / I.Com / Equivalent qualification with at least 50 % marks are eligible to apply for BS Geography Program.

3.5.1.10 ELIGIBILITY CRITERIA FOR BS PHYSICS

- 3.5.3.1 The List of eligible / provisionally eligible candidates, prepared by respective department, for admission test for specific disciplines of BS will be uploaded

- on university website along with the prescribed date/schedule, by the Registrar Office through Web Office.
- 3.5.3.2 The candidates who qualify the admission test as per LCWU/HEC policy shall be declared eligible for interview.
- 3.5.3.3 The list of eligible / provisionally eligible candidates, prepared by respective department, for interview will be uploaded on university website along with the prescribed date/schedule, by the Registrar Office through Web Office. The interview shall be conducted by Departmental Admission Committee.
- 3.5.3.4 Final Merit Lists will be prepared by the respective department and will be displayed on University Website, by the Registrar Office through Web Office.
- 3.5.4 For programs which do not require admission test, the Merit Lists will be prepared by the respective department on the basis of marks obtained by the candidates and will be displayed on University Website, by the Registrar Office through Web Office.
- 3.5.5 The candidates shall be required to visit respective department of University along with original documents for verification on the prescribed date/schedule.
- 3.5.6 After successful verification of the original documents, the respective department shall issue an admission slip to the candidate. The admission fee challan shall be issued by Fee Section of Treasurer Office in lieu of that admission slip. The candidates shall submit the Fee and shall submit the receipt to respective department for issuance of Roll No.

3.5.7 ADMISSION FORMS REQUIREMENTS

4. COMMENCEMENT OF CLASSES

The classes of all academic programs shall commence as per academic schedule of the Session, notified by the Controller of Examinations. The same shall also be displayed on the University Website.

5. DEPARTMENTAL ADMISSION COMMITTEE

The Departmental Admission Committee shall consist of Chairperson (Convener), two faculty members of the department, and admission coordinator (secretary).

6. REGISTRATION & ISSUANCE OF ROLL NO.

6.1. The students admitted in any academic program shall be registered and enrolled by the Registrar office as per Registration Regulations of LCWU, Lahore

7. TRANSFER/SHIFTING OF ADMISSION FROM ONE PROGRAM TO ANOTHER

- 7.1 A student may apply for Transfer/Shifting of submitted admission form from one program to another, during admissions or within a maximum of 7 working days after the commencement of regular classes. Such applications shall be scrutinized and processed by the Registrar Office for approval from the Director Academic Planning. Such applications may be allowed subject to following conditions:
 - i. Availability of Seats
 - ii. Eligibility criteria of the respective admitting program
 - iii. Merit of the respective admitting program

- iv. Recommendation of the COD/in-charge of respective admitting department
- 7.2 No application for the change of program will be entertained after due time.

8. FEE REFUND / TRANSFER

- 8.1. A newly admitted student may apply for fee refund to Treasurer Office through respective Department. The university shall process the refund application as per HEC national refund policy.
- 8.2. In case of transfer/shifting of admission from one department to another, the fee deposited in previous departmental account shall be transferred to admitting department account by office of the Treasurer upon application of the candidate/student.

9.3 The maximum cumulative number of admitted students in MS / MPhil and PhD programs in a specific discipline shall not exceed the limit of student-supervisor ratio and teacher-student ratio, as defined by HEC.

- 9.4 The number of student enrolled / seats in any program can be increased / decreased as per requirement of the accreditation council and / or approval of statutory bodies / Vice Chancellor.
- 9.5 Considering the professional nature of various degrees, the minimum admission in-take for all the regular/self-supporting M. Phil. programs being offered by the departments under Institute of Pharmacy, MS Electrical Engineering, and MBA Executive, shall be 10.
- 9.6 In case of lesser number of admissions in any program, the class can be commenced by concerned Chairperson, after seeking special approval from the Vice Chancellor, through the office of Director Academic Planning.

11.2. GENERAL TERMS & CONDITIONS

- i. The Candidates from Northern Areas and other provinces shall submit their Admission application against the reserved seats through the Secretary Nomination Board, Northern Areas or through concerned provincial government respectively. Applications of only those candidates will be entertained, who have passed their HSSC Examination from the College situated in the respective Area.

 - c) The student will approach the Pakistani Mission abroad for Visa and will submit the following documents:
 - Application Form (Student Visa Form)
 - Photocopy of passport
 - Photograph
 - Educational Documents
 - Admission Letter of University
 - All other documents required by the Pakistani Mission abroad.

- d) The Pakistani Mission abroad forwards all the documents to the Ministry of Foreign Affairs, Islamabad for further processing.
- e) The Ministry of Foreign Affairs, Islamabad forwards all documents to the Ministry of Interior for security clearance and a copy to Ministry of Education, Health and HEC, Pakistan.
- f) As per policy, the Ministry of Interior takes about four weeks to complete the process and sends Visa advice to the Mission concerned and copy to the Ministry of Foreign Affairs and HEC, Pakistan.
- g) The HEC sends information of Visa advice to Ministry of Education, Health and LCWU, Lahore.
- h) Visa to be issued for duration of studies will be renewed annually, subject to security clearance.
- 11.4.3. The selected candidates shall pay the dues by the dates notified, otherwise their seats will be cancelled.
- 11.4.4. Due to limited seats in the hostel, hostel seat will be granted on merit only.
- 11.4.5. The candidates from the other universities shall provide NOC from their respective universities.
- 11.4.6. Admission on general seats shall be granted strictly on merit.

11.5. ADMISSION REQUIREMENTS FOR DAUGHTERS OF OVERSEAS PAKISTANI

- 11.5.1. General conditions for admission against seats reserved for Overseas Pakistanis Daughters shall be the same as for the candidates applying for admissions to BS Regular Programs.
- 11.5.2. At-least one of the parent of the candidate must be Pakistani National and is working / engaged in a business in a foreign country.
- 11.5.3. In case a candidate's parent is employed in a foreign country, they should submit a certificate to that effect from the employer along with proof of residential status. In case a candidate's parent is engaged in business in a foreign country, they should produce proof of their business/office and residential status along with the Admission Form.
- 11.5.4. The candidate applying on this basis shall apply for admission directly to the University along with the other candidates.

12. GENERAL TERMS & CONDITIONS

- 12.1 Candidates working in Government / Semi-Government institutions have to submit NOC (No Objection Certificate) from concerned organization.
- 12.2 There is no reserved Quota for admission in PhD Program.
- 12.3 PhD is being offered subject to availability and consent of Supervisor/seats.

13 SELF SUPPORTING PROGRAM

- 13.1 Any department can offer admission in level 5, 6, and 7 programs on selfsupport basis after fulfillment of requirements and approval from statutory bodies.
- Self-support program shall be offered only after completing minimum number of admissions in the regular program.
- 13.3 There is no reserved Quota for admission in self-support Programs.
- 13.4 Student must visit the university website for the details of Self support programs offered at LCWU at the time of admission.

14 ADMISSIONS IN BS/EQUIVALENT DEGREE PROGRAM IN FIFTH SEMESTER ON THE BASIS OF ASSOCIATE DEGREE

- 14.1 Students having completed Associate Degrees from any university shall be eligible for admission in the fifth semester of the BS/equivalent degree program offered in the same discipline, however, departmental equivalency committee shall evaluate the deficiency requirement. The student shall have to study deficiency courses (if any) along with forthcoming semesters.
- The minimum eligibility for admission in the fifth semester of BS/Equivalent degree program is 2.30/4.00 CGPA in Associate Degree.
- 14.3 The admissions in fifth semester of BS/Equivalent degree program is subject to availability of seats as per inter-se-merit for the specific batch.
- 14.4 There shall be no admission on the basis of reserve seat / quota basis / cocurricular activities / Hifz-e-Quran in fifth semester of BS/Equivalent degree program.

15 ADMISSIONS IN UNDERGRADUATE PROGRAMS ON FIRST YEAR MARKS BASIS.

- 15.1 Admission to Undergraduate programs may also be offered on the basis of intermediate First Year or equivalent marks, provisionally. However, after declaration of Intermediate results by BISE concerned, the student shall have to submit complete pass Result Card.
- 15.2 In case of supplementary/failure in any subject in Part-II or Incomplete result, the provisional admission shall stand cancelled.
- 15.3 In case, after declaration of Intermediate Part-II result, any student does not fulfil the eligibility criteria of accreditation council of the respective program, then her admission shall be cancelled.
- The University authority may determine merit and admit candidates either on the basis of Part-I result solely or on the basis of Complete/Combined Part-I and Part-II results, whichever is feasible. However, a uniformity for a particular intake of batch (irrespective of phases) shall be maintained so that no disparity in merit occurs.

16 FORCE MAJEURE

- 16.1 Late admissions after due date, in ADP / BS / MS / MPhil / PhD shall be allowed on hardship basis. The concerned Chairperson and respective Dean of Faculty shall recommend and forward the applications to Registrar Office. For such late admissions, Entry Test / Interview shall be re-conducted for applicants of ADP/BS (where applicable), and all disciplines of MS, MPhil and PhD. Late admissions shall not be entertained after commencement of regular classes, in any case.
- All those applicants who have submitted applications in a particular program at ADP/BS Level, but due to high merit, they are not selected, they can shift/transfer their forms in the program / department of their choice on merit subject to fulfilling all admission eligibility criteria for the program, without applying afresh. The concerned Chairperson of admitting department shall recommend and forward such applications to Registrar Office. The registrar office shall process all such applications for approval from Director Academic Planning. Such shifting of forms shall be permissible within a maximum of 7 working days after the commencement of regular classes.

- A candidate may apply for admission to up to three ADP / BS / MS / MPhil programs simultaneously, prioritizing her preferences. If necessary, the number of program choices on the admission form may be increased with the approval of the Vice Chancellor to accommodate seat availability. Since applicant can apply to multiple programs, departments may prepare a merit list that includes more candidates than the total allocated seats. However, the total number of admissions shall not exceed the allocated seats unless authorized by the Vice Chancellor.
- Depending upon the nature / need of the discipline, complexity of the entry test for ADP/ BS / MS / MPhil / PhD, and availability of seats, the respective Chairpersons may standardize / harmonize the admission test scores for all the applicants, to fill the number of seats, after seeking approval from the Vice Chancellor.
- 16.5 In genuine cases, the Treasurer may facilitate the applicants by making installments in fee on need basis.
