#### **INTRODUCTION**

#### MS Fine Arts program

Fine Arts Research Center IVAD offers MS (MPhil) degree of two years (4 semesters of 36 credits). It is enhanced by advanced curricula that provide a powerful set of professional skills and critical understandings for our students to mobilize at the completion of their degrees.

This curricula brings students from all areas of Fine Arts study together for a common understanding to the world art history; pre history to the current issues in the art world – its structures, organizations and research, as well as its essential skills and protocols. Site visits, lectures and juries, creative practice, case studies and workshops provide students with new information and context, as well as real-world examples and experiences.

This degree offers two major domains of fine arts; one is Art History and second is MS- Studio Practice.

Since the inception of this institute Fine Arts Research center was approved as a separate department but university does not recognize its entity as a separate department. For this we are running the research program with very limited resources.

Limited resources are available only for BFA program studios as mentioned in Standard 7.3

#### • Resources available for computing facilities

Resources are not available for the computing facilities for students as mentioned in Standard 7.1
